- The Indian Express Industry is one of the fastest growing express industries globally. It has grown at 15% CAGR between FY12 and FY17 and is estimated to be worth INR 22,000 cr in FY2017. The industry is further expected to grow by 17% CAGR to INR 48,000 cr by FY22.
- The Indian Express Industry has strong presence in the domestic Indian market and the international (cross-border) markets and is a significant contributor to the economy both financially and for employment generation.
- The Indian Express Industry currently provides direct and indirect employment to 1.6 million and is expected to grow to 2.6 million by FY22.
- The express industry considers employment as one of the most important pillars of its growth and sustenance.
